Governor Bob Wise Outlines Accomplishments and Goals

Government Reorganization,
 Malpractice Reform and Fleet
 Reduction Will Affect the
 Department of Administration

In his third State of the State Address, Gov. Bob Wise focused on such issues as malpractice reform, government reorganization and reduction of the state's vehicle fleet.

Wise proposed medical malpractice reform that addressed both the tort system and economic pressures created by national insurance companies. "My number one commitment is to the health and safety of the citizens of West Virginia," Wise said. "We must guarantee that every West Virginian has access to the doctors he

or she needs, and every West Virginia doctor has access to reasonably priced medical malpractice insurance."

The proposal modifies the qualifications for expert testimony, limits liability for non-economic loss; modifies joint and several liability and contribution; limits damages paid by collateral sources; and limits liability for trauma care.

In addition, this bill requires \$20 million from the tobacco settlement medical trust fund to offset the cost of continuing medical liability protection for

Empowering Employees to Make Change

Governor Bob Wise Solicits Ideas from State Employees to Enhance Programs

During an employee town hall meeting in December, Gov. Bob Wise introduced a website that provides state workers an opportunity to suggest costeffective changes to state programs and services.

The West Virginia Employee Communication Network (WVECN) can be accessed at www.wvgov.org/wvecn. "You can communicate directly with us. I want to stress 'with us', because we have set up a team that will take in all the suggestions," Wise said. "Yes, they will be farmed out to agencies, the secretaries and the department heads, but there also will be a central repository in which I will be reviewing them and the members involved in the restructure." Suggestions may be made anonymously if the person so chooses.

Approximately 1,000 suggestions already have been received, according to Tina Holmes, a public information specialist, who is working on the project. Holmes stated that the state of Virginia has a similar program, which received about 250 suggestions within the first two weeks. West Virginia's program received nearly 500 suggestions within the first 48 hours!

Wise is hoping to use many of these suggestions to make positive changes. "My belief has always been, when we have a problem, get everyone around the table to solve it," he added.

Aviation Day Offers Training and Focus on Air Safety Procedures



One day is dedicated each year in which our state pilots keep their feet steadfast on the ground rather than performing *normal* duties of flying state officials to necessary business engagements.

On January 28, Aviation Services offered Aviation Day, which primarily focuses on safety. This day is set aside for training and a review of safety procedures in a continuing effort to be prepared for any emergency which may arise while flying in state aircraft.

All aviation personnel will participate, including pilots, mechanics, the scheduler and members of the State Police who accompany the governor and his family for security purposes.

This is a day for all those involved to review safety procedures, according to Chief Pilot Keith Wood. He added that scenarios in which things can go wrong during the flight, such as mechanical failures and medical emergencies, are discussed in an effort to be prepared for any emergency.

All Aviation personnel are trained in CPR; however, on this day they review this training, including the use of the heart defibrillator which is

Updating Your Beneficiary Information

Have you recently made a change in your marital status, the arrival of a new family member, a death in the family or other changes in your family status? You may need to update your beneficiary form that is on file at the Consolidated Public Retirement Board.

When changes occur in your family situation, it is important to review and update your beneficiary designation promptly. You may name a new beneficiary at any time prior to your retirement.

doctors who switched from private insurance carriers to the Board of Risk and Insurance Management.

Wise also introduced bold measures to restructure state government. This restructuring plan includes reducing the size of the Governor's Cabinet by eliminating the post of Commerce Commissioner and combining the posts of Secretary of Tax and Revenue and Secretary of Administration; merging the Governor's Office of Technology with the Information Services and Communications Division: combining the Governor's Cabinet on Children and Families and the West Virginia Bureau for Children and Families into a single agency

that gives families one-stop access to assistance in meeting children's needs; and signing an executive order to reduce the vehicle fleet by 15 percent by March 31.

Wise also introduced legislation to raise the cigarette tax to 55 cents per pack; lower the blood alcohol content level to .08; and enact all-terrain vehicles safety regulations.

"We have a historic opportunity this year. We must show that we are worthy of the trust the citizens of this state have placed in our hands," Wise said.

"This is a bold agenda in tough times, but my inspiration and my guide are our West Virginia people. We will leave our children a great legacy if we unite for the entire state and place this government on a sound footing."

Valentines Day from A Smaller Perspective


A group of 4 to 8 year-olds were posed this question, "What does love mean?" The answers received were deeper than what you might expect:

available on the airplane.

The mission of the State Aviation Division is to enhance the efficiency and effectiveness of state government by providing safe and professional aviation support. Reducing travel time and increasing productivity for state executives are primary goals of the Aviation Division.

Access and usage of state aircraft are limited to state agencies and the Legislature. State-owned aircraft will not be used for transportation when state interest is not served.

The state's aircraft is a

Beechcraft King Air 350, known for its comfort, speed, reliability and safety. It is equipped with the latest avionics, including Universal Flight Management System, GPS navigation, TCAS and weather radar. The pressurized cabin enables flying at high altitudes above the weather. The King Air 350 can seat nine passengers and has an average cruising speed of 345 mph. All destinations in West Virginia can be reached in less than 45 minutes.

The Aviation Division can provide transportation to most any location in the state or across the nation. One to two *days* of travel by auto can be accomplished in one to two *hours* of flight.

Today's executives agree that time is their most valuable resource. Air transportation is an important business tool to save time and maximize productivity of personnel. Effective time management is critical to the success of any organization.

This is certainly true of state government. The state, by

maintaining an Aviation Division, is able to move key personnel around the state or anywhere in the country. In many instances this is more efficient and cost effective than auto, commercial airline or charter service.

The Aviation Division can provide the following services:

- → Greater effectiveness in providing the state with travel flexibility.
- → Access to travel points not served by commercial airlines.
- → Less travel time that can be spent preparing for meetings, fine tuning presentations or attending private conferences.
- → Cost savings due to more efficient use of work time and a reduction of out-ofoffice time and hotel expenses.
- → Reliable transportation and dependability of skilled maintenance and flight crews.
- → Express air courier and emergency services.

The Aviation Division pilots collectively possess more than 25,000 hours of flying experience. Each pilot holds an ATP (Airline Transport Pilot) rating, the same as that required for a captain of any major U.S. airline. The experienced aircraft maintenance chief holds an FAA certified Aircraft Inspector certificate.

Governor Wise Announces Free Generic Drugs for Cold and Flu Season for PEIA Members

Gov. Bob Wise directed the Public Employees Insurance Agency (PEIA) to once again waive the copay for certain generic antibiotics for members of its PPB Plan during the months of January, February and March.

"We have accomplished a great deal with this program," Wise said. "Last year, the use of generics rose 3 percent, resulting in a savings of nearly \$2 million. That does not include the savings our members gained by not having a copay."

During these three months, the state is eliminating the copay on these antibiotics in an effort to encourage PEIA members to use generic drugs. The waiver will apply to certain generic antibiotic medications for PEIA PPB Plan members who have met their annual prescription drug deductibles.

"We feel that once members experience firsthand that generics are as effective as brand-name drugs, they will be more likely to use them in the future," said PEIA Director Tom Susman.

Last year, PEIA and its members spent nearly \$157 million in prescription drug coverage. Fourteen percent of that was spent on generics and 86 percent on brand-name drugs. According to PEIA, only 42 percent of the prescriptions paid by PEIA were generic. For every 1 percent of the brand-name drug usage that moves to generic, PEIA saves at least \$600,000.

PEIA hopes this program will continue to encourage physicians to prescribe more generics. As part of the program, PEIA is providing physicians with information on generics and their benefits.

"Obviously, our first priority and concern is the well-being of the patient. However, because FDA requires generics to have the same quality, potency, active ingredients and be therapeutically equivalent to the brand name, we hope that doctors will prescribe the generic, if appropriate," commented Susman.

Use of generic medications will save the agency — and its members — money. The normal copay for generic medications is \$5, as opposed to \$15 for preferred brandname drugs or \$30 for non-preferred.

How to Fight Fatique in the Workplace

A Time for Change

As a result of Gov. Bob Wise's **State of the State Address**, many of our employees have expressed concern over future changes in state government, specifically within the Department of Administration.

In the proposed Government Reorganization Bill, it has been suggested that the Department of Administration and the Department of Tax and Revenue be combined. This proposal is one of which Tax Secretary Brian Kastick and I fully support. Eliminating the cabinet post for one and having one cabinet secretary oversee both the revenue received and disbursed by the state makes economic sense.

Merging these departments is projected to save more than \$3 million annually. The savings would come from combining many jobs and computer systems and crosstraining individuals to do jobs ordinarily done by others.

Many questions have been asked which I am unable to answer at this time. As the bill progresses through the Legislature, I will keep our employees aware of the status of this bill and any effects it may have on our department.
