# PEIA Director Ted Cheatham Prepares for New Challenges in Health Care for Members

On September 27, 2006, Ted Cheatham was appointed by Gov. Joe Manchin as director of the Public Employees Insurance Agency (PEIA). Cheatham brings to state government more than 15 years of executive and management experience in the health care and insurance industries.

From 1999-2003, he

served as President and CEO of the Charleston-based Carelink Health Plans. During his tenure, he spearheaded a restructuring of the organization's operations that resulted in a 74 percent growth in the net worth of the organization, a subsidiary of Fortune 500 firm Coventry Health Care.

Most recently, he served as business director with Unisys in Reston, Virginia, leading all business development efforts in seven U.S. states. Unisys is a worldwide technology services and solutions company. He has also worked with major health insurance providers in Mississippi and California.

"Ted Cheatham is an accomplished executive in the health insurance industry, and I am pleased that he has agreed to oversee our efforts on a state level," said Gov. Joe Manchin. "He brings a wealth of experience to this position that is only further enhanced by his strong familiarity with the working structure of PEIA as a past leader of one of the agency's largest provider organizations."

The U.S. Department of Agriculture (USDA) and Congresswoman Shelley Moore Capito recently coordinated a free Broadband Summit in Charleston to discuss the USDA's Rural Utilities Service broadband loan/grant programs. A reception followed the nascent Community Connect Foundation.

This foundation, a community technology organization,

and local government employees and their dependents and administers life insurance and optional health and financial services to public employees.

With a dual bachelors degree in finance and personnel management from the University of Arizona, he earned a masters degree in business administration from Troy State University and a Juris Doctorate from Whittier College School of Law. He is also a commissioned officer in the United States Army.

Cheatham interviewed with Cabinet Secretary Rob Ferguson and Governor Manchin. "The governor has a good vision as does Secretary Ferguson. They convinced me that I can help the state of West Virginia be a better place today and a better place to leave for our children."

He does not anticipate any immediate changes to the organization. Emphasizing the quality of PEIA's staff, he said, "They're very talented and understand the fund. The managers have nice leadership styles and a good grasp of where we need to go. One person can't do it alone. It will have to be a team effort."

Focusing on a team effort, Cheatham plans to schedule an off-site meeting for his leadership to build a strategic plan for next year, in order to streamline operations. "The management team needs to concentrate on strategic planning and tactical business development plans to better serve our customers," he said.

#### Governor's Mansion Project Complete

# First Lady Gayle Manchin Offers Tour of Renovated Governor's Mansion

As part of the Capitol Building Commission meeting on October 12, 2006, First Lady Gayle Manchin graciously opened the doors of the Governor's Mansion, inviting members of the press to come and see first-hand the results of the renovation project with which she has worked closely since her husband, Gov. Joe Manchin III, first took office in January of 2005.

Since its completion in 1925, fifteen governors and their families have called this Georgian Colonial structure their home. The Mansion was designed by Walter F. Martens and, surprisingly, took nearly the same amount of time to build as did the east and west wings separately.

Although the third story was not included in the original plans when the Mansion was originally built, it was added in 1946. Additional updates and maintenance have been minimal through the years for unknown reasons; however, this historic structure is definitely worthy of preserving.

When the Manchins began moving into the Mansion, they soon discovered the poor condition of the home, and to ensure its integrity, a renovation project of the second and third floors began in October of 2005 and was recently completed.

Private funds, totalling approximately \$500,000, were donated to this project to pay for the fixtures and furnishings of the interior.

Public funds were used in

the structural, architectural, mechanical, electrical and security expenditures of this project.

As with most renovation projects on older structures, correcting known problems often leads to

unexpected issues, such as plumbing and wiring issues. However, there were a few pleasant surprises in the Governor's Mansion, including the discovery of two skylights that had been covered by ceiling tiles had been removed on the third floor.

They also found beautiful hardwood flooring hidden beneath worn out carpeting. Members of the press were given photographs prior to the renovation project in order to compare the "before" conditions with the newly renovated features.

The end result of the Governor's Mansion renovation project was the proper restoration of a historical structure. West Virginians and future first families for years to come will enjoy the beauty of this residence.

# **Electronic Notification of Deposit for Pay Checks**

Beginning November 15, 2006, the Department of Administration will no longer issue employee paper payroll stubs. Employees will retrieve payroll information via Electronic Notification of Deposits (ENOD).

Employees need to enroll as soon as possible by visiting the Auditor's Office website at **www.wvauditor.com** and click on "ENOD Enroll Now".

The benefits include:

 The employee will have access to their payroll information (up to five days prior to payday);

- 2. Safely and securely view their 2004 and 2005 W-2s and reprint them when needed:
- 3. Those receiving overtime pay will have the ability to see the exact amount to be direct deposited into their account (up to five days prior to payday).

Employees who do not have access nor wish to enroll in ENOD must contact the Payroll Office at 558-3482. Your notification of deposit will be mailed to your home address on payday.

# The Purchasing Division Resurrects the Inspection Program to Assist State Agency Purchasing Agents



With the re-creation of the Purchasing **Division's Inspec**tion Program, the division's new inspectors (I-r) Shane Hall, Susan King and Junior **Blount will be** working with agencies as inspectors, reviewing purchasing transactions as well as serving as valuable resources to agency personnel.

After the purchasing reform legislation that passed during the 2006 Regular Session of the Legislature, issues were raised in regard to the availability of staff needed to address and enforce the new requirements set in statute and rule.

As a result, the Purchasing Division has resurrected the inspection program that has not been fully functional for nearly 15 years.

"We were the first state in the country to have inspectors years back," said Purchasing Division Director Dave Tincher. "Many states now have inspectors and even modeled their program based on ours. Unfortunately, over the years, we lost funding and as inspectors retired, we weren't able to replace them," Tincher added. There has been an increasing interest from different areas of government for the Purchasing Division to get 'back into this business'.

The inspection program will serve as a resource for questions that the agency procurement staff may have regarding the various programs and services offered by the Purchasing Division. The inspectors will be reviewing purchasing transactions issued under the delegated purchasing authority to ensure

completeness and accuracy. Training will also be provided to agency personnel, if, and when needed.

"There is one primary difference from our previous inspection program to our newly developed program," said Tincher, "and that is the addition of technology. In the past, the inspectors had to knock on doors, find the person who handled procurement, and have them open their file cabinet and manually retrieve records. With today's technology, much of the preliminary work can be done before the inspector even leaves the office."

Tincher said he believes this program is desperately needed because the inspection program will offer agencies a sense of how well they are performing their function and will provide the necessary guidance when needed. "It is a positive thing we're bringing back. We just want to make sure that the people who are responsible for the purchasing functions understand the process and procedures and are able to perform their duties effectively and efficiently. We want to make sure we're getting the best value for the tax dollars we're charged to spend," said

Three inspectors, Susan King, Shane Hall and Junior Blount, have been hired and are currently being trained on the West Virginia laws and regulations as they pertain to the state procurement. They said they are enthusiastic to begin working with the state agencies.

## PEIA Recognized by WVU for Wellness Program

The West Virginia Public Employees Insurance Agency (PEIA) received the 2006 Dean's Service Award, sponsored by West Virginia University, for its involvement and support of the Dance Dance Revolution Program (DDR).

PEIA Wellness Coordinator Nidia Henderson accepted the award on behalf of the agency. The WVU School of Physical Education and the West Virginia Motor Development Center, under the leadership of Ware Distinguished Professor Dr. Linda Carson, along with PEIA, Konami Digital Entertainment, Mountain State Blue Cross/ Blue Shield, Acordia and the West Virginia Governor's Office have joined efforts to place DDR video games in all public West Virginia middle and high schools to increase students' physical activity.

"As one of the largest insurers in West Virginia, the Public Employees Insurance Agency is painfully aware of the obesity epidemic faced by our state and our nation. Over the past several years, West Virginia has seen health care costs climb. Last year, we spent \$96 million on obesity related claims. We realized that we had to intervene," said PEIA spokesman David Bailey.

PEIA realized a way to convert that "screen time" into physically active time by using the video game Dance Dance Revolution (DDR). DDR uses a dance pad and requires players to move their feet to operate the game. They found that kids responded to the game with its captivating graphics and songs.
