With the raging floods in southern West Virginia, Governor Bob Wise urged all state agencies to assist in any way possible to ease the lives of those affected by the rising waters.

The Department of Administration took action in many ways. Jane Fouty and Ada Lewis of the Division of Personnel coordinated a flood relief collection to assist the individuals who, in many cases, lost all of their personal possessions. Cleaning supplies were in greatest demand.

Many other departments conducted similar relief efforts and the General Services Division employees manned a central location on California Avenue to collect the items and assisted in loading

Governor Bob Wise has been knocking on doors this summer to promote the Children's Health Insurance Program. CHIP offers free or low cost health insurance for children of working families to get the medical care they need to grow into strong healthy adults.

"I'm going to be walking through neighborhoods, knocking on every door - doing whatever it takes to find every child and get them signed up for CHIP," Wise said. "Every parent should have the peace of mind knowing their kids can get health care when they need it."

Current enrollment for WV CHIP stands at 20,662, a 34 percent increase since January of this year.

property, Secretary Burton, Deputy Secretary Dot Yeager, Executive Assistant Debbie Bradford, Purchasing Director Dave Tincher and Public Information Officer Diane Hollev visited WVSASP to take a tour of the facility and to determine the types of property that could be transported for this relief initiative.

A special session was called by Governor Wise to address the millions of dollars in flood aid which was to be allocated to the 24 counties that were declared disaster areas. According to state statistics, the government's flood-related expenses exceeded \$125 million.

The Children's Health Insurance Program (CHIP) also took part in the relief action by replacing eyeglasses that were lost or damaged in the recent flooding for children covered by CHIP, the state insurance plan for low-income families.

DOME FACTS

• The dome has two layers, with an air pocket in between. The top layer is the gilded masterpiece and the smaller, inner layer can be viewed from the Rotunda.

• There are at least 5 lookout points inside and outside the dome which can only be reached by spiral staircases and ladders.

• The crystal chandelier that hangs from the center of the inner dome is approximately 2 tons and is lowered partially when the legislature is in session. It is completely lowered for cleaning and display during inaugurations. The 4,000 pound ornament contains over 100 light bulbs and is hand cranked.

• An emergency light is located at the top of the dome and is only lit during a statewide emergency, such as the flooding many West Virginians experienced this summer.

Preserving the State Capitol's Dome Becomes Historical Issue

The spiral staircases seem to go on forever, one after the other. Then climb at least a dozen flights of regular stairs and ladders...But the reward is worth it.

The reward is leaning out of the tiny windows and over the iron handrails to grasp a view of the city of Charleston that only a few will ever see. Standing atop of the State Capitol Building's golden dome, one may imagine what Architect Cass Gilbert had in mind.

The beautiful dome of the Capitol Building is truly a symbol of West Virginia. It is unique, majestic...and, unfortunately, deteriorating.

Commuters may have observed the coal-colored blemish on the south side of the dome that appears most noticeably in the winter. Taking a closer look, one finds that there are many more problems. The General Services Division knows about the deterioration and

has set its plan of action. One of the problems is that the joints in the dome's limestone base are separating from their caulking. "One of the projects that we are developing specifications for," explains Tim Lee, Assistant Director of General Services, "is to actually have the jointing and painting redone and resecure the lining into place."

In other words, General Services is hoping to scroll back the aging process. In this case, they are investigating the best way to fix and strengthen the joints between the limestone blocks that have deteriorated as a result of weather conditions.

The biggest project for General Services, however, is the actual re-ailding of the dome. This is a project that has not been tackled for some time. According to Acting Deputy Director Bill Pauley, the last re-ailding was in the mid-1980's, and it was not complete. Over time, Lee points out, the gold has come loose from the metal. "We've got a lot of exposed areas up there that do not necessarily get noticed unless you are close to it," he adds. These exposed areas and, of course, the notorious "black spots" are the reason for the re-gilding.

So what does re-gilding entail? "Re-gilding is done with sheets [of gold] laid on the surface of the dome," says Paul Prendergast, Occupational Health & Safety Coordinator, for General Services. However, before

they can lay on the gold, research is needed. "We have a group, Swanke-Hayden, from New York, who are experts at re-gilding," said Acting Director David Pentz. He added that this company will be taking a $4' \times 6'$ sample, or "coupon" from the dome, which will be taken to a lab and tested. The results will hopefully determine why the dome surface has discolored and peeled. Solutions to refurbish the dome will be discussed. Many of the decisions regarding the dome renovation will be made in committees, including representatives from many state agencies.

What about the cost? This factor is yet to be determined, though such renovations in other states have cost substantially. "As far as I'm concerned, the dome will be the most significant project that we will deal with," Pentz said. "It is certainly the most visible [project]...It's a symbol of our state and of our city. Whatever we do, it's going to be done right!"

Attention PEIA PPB Plan Members: Are You Aware of Recent Changes to Your Plan?

The Public Employees Insurance Agency recently implemented several changes for Plan Year 2002, which began July 1, 2001. Some of these changes are detailed below; however, if you have additional questions, please contact Customer Service at (304) 558-7850 or toll-free 1-888-680-7342.

Precertification for Allergy Testing

Effective July 1, 2001, allergy testing requires precertification. For in-network services, (precertification is the provider's responsibility and if the precertification is not done, the pro-



vider takes a 30% penalty. The provider should contact Intracorp for precertification. In-network allergy testing is covered at 20% coinsurance after the deductible is met.

Prior Authorization for Non-sedating Antihistamines

The antihistamines include Allegra, Zyrtec and Claritin. On August 1, 2001, any prescription for these non-sedating antihistamines requires prior authorization from Merck-Medco. The prior authorization process can be started by the member, the physician or the pharmacist by calling Merk-Medco at 1-800-711-3808.

Retail Maintenance Network

PEIA offers a Retail Maintenance Network of pharmacies that will fill your 90-day maintenance prescription for just two copayments. You can buy two months and get one month free. All Kroger, K-mart and Rite-Aid pharmacies are members of this network, along with many other local pharmacies across the state. A complete list can be found on PEIA's website at **www.wypeia.com** or in the Summary Plan Description.

Timely Submission of Claims

Members and providers now have 6 months from the date of service to submit a claim to be considered by PEIA, when PEIA is the primary insurance. If PEIA is secondary, the time limit is six months from the date of the Explanation of Benefits from the primary plan.

Notice to PEIA Enrollees Concerning Election for Plan Exemption from Certain Federal Requirements: Under a 1996 Federal law, group health plans must generally comply with certain requirements; however, the law permits state and local governmental employers that sponsor health plans to elect to exempt a plan from these requirements for any part of the plan that is self-funded by the employer, rather than provided through a health insurance policy. The only practice effect to PEIA members is that the PEIA PPB Plan has made a ten dollar reduction for family coverage and a five dollar reduction for single coverage in premiums for members who certify that they and/or their covered dependents do not use tobacco.
