Ribbon Cutting Ceremony Conducted for New State Office Building in Downtown Clarksburg

Governor Earl Ray Tomblin joined other state and local officials to dedicate a new state office building in downtown Clarksburg at the end of October. Department of Administration employees from the Purchasing, Real Estate and General Services Divisions all played a key role in the planning, design and construction of this office building.

"The Department of Administration's mission is 'to operate a cost-efficient, cus-

tomer-oriented service department whose actions are transparent to the taxpayers resulting in innovative solutions and quality results for a government that effectively serves West Virginians," shared Acting Cabinet Secretary Mary Jane Pickens during the ceremony. "I trust that the Clarksburg State Office Building will serve as another shining example of our mission."

The ceremony featured a welcome from City of Clarksburg Mayor Catherine Go-

ings, special remarks from Harrison County Commission President Ronald Watson, and an invocation by local Reverend John F. Koerner. The National Anthem was performed by Alex Mazza, who is a senior at Notre Dame High School.

Residents of Harrison County and North Central West Virginia will now have convenient access to the Department of Health and Human Resources, Division of Motor Vehicles, Workforce West Virginia, Division of Rehabilitation Services, State Tax Department, and the State Auditor's Office. During the day of the ribbon cutting ceremony, state agencies were already moved into the building and serving local citizens.

"In addition to the convenience of services, we anticipate a tremendous economic impact in the downtown Clarksburg area for years to come," said Governor Tomblin.

The facility, which spans four floors including a lower level and totaling 76,098 gross square feet, hosts a total of 180 state employees. Construction was completed on the office building in July of 2016.

PEIA Diabetes Wellness Program Aims to Improve Health and Quality of Life

The West Virginia Public Employees Insurance Agency (PEIA) offers its members a variety of free or low cost wellness programs aimed at improving their health. For individuals with diabetes, PEIA specifically administers the Face-to-Face Diabetes Management Program.

The Face to Face Diabetes Program is available to all PEIA Preferred Provider Benefit plan members who have been diagnosed with diabetes, including gestational diabetes. The goal of the program is to help individuals improve their quality of life and educate them on diabetes self-management. By participating in the program, members can also expect to save money since co-payments are waived on generic and preferred brand diabetes-related prescription drugs and supplies. Though still responsible for their deductible, this can add up to substantial savings.

To qualify for this program, individuals must have a primary care physician and be willing to attend regular appointments with a Face-to-Face provider for counseling and other health educational services. Fleet Office Cautions Drivers of Potential Deer Danger While Driving

Each year there are approximately 1.6 million deer-vehicle collisions. These collisions result in 200 fatalities, tens of thousands of injuries and over \$3.6 billion in vehicle damage. With deer becoming more active during the fall and winter months, the Fleet Management Office would like to offer some safety tips for drivers.

Wear your seat belt and keep your distance. While wearing your seat belt may not prevent a collision, it can help reduce injuries. Keeping six seconds between you and the car in front of you will allow you more time to react if the car in front of you hits a deer.

Watch for more than one. Deer often travel in herds. Where you see one deer, more are likely to be nearby. If one crosses the road in front of you, be aware more may follow.

Stay alert after dark. Deer are most active from sunset to midnight and the hours after sunrise. Slow down and stay alert during these hours when your vision is not as strong.

Use your high beams. When possible, use the high beams while driving. Not only will this illuminate more of the area, it can also help show animals' reflective eyes. While their body may be hidden in the dark, a deer's reflective eyes can warn you that they are around.

Don't swerve. If you see a deer, calmly brake and stay in your lane. Swerving could result in losing control of the vehicle or moving you into a darting deer's path.

Honk and flash your lights. Flashing your lights and one long blast of your car's horn may help to scare deer out of the road. This will also help alert other drivers to be cautious of potential danger.

If you should hit a deer, be sure to follow these steps:

- 1). Pull over to the side of the road when it is safe to do so.
- 2). Turn on your hazard lights. Do not leave your vehicle until you are sure it is safe.
- 3). If there are injuries, call for emergency services or call the police to report property damage.
- 4). Stay away from the deer. A live deer may be dangerous, if approached. If you suspect the deer may still be alive, let authorities know if the deer is in a dangerous location.
- 5). If you are in a state vehicle, call your Fleet Coordinator as quickly as possible to report any damage to you and the vehicle.



West Virginia's Organ Cave Full of Wonder, Science and History

Organ Cave, located in the heart of Greenbrier County, is the largest cave in West Virginia and the 3rd largest in the nation. It has more than 45 miles of mapped passages with over 200 leads yet to be mapped and surveyed.

Designated as both a National Natural Landmark and a National Landmark of Historic Places, Organ Cave is the site of the first Prehistoric three-toed sloth discovered in the late 1700s.

State Government Receives National Attention for Financial Reporting

The Government Finance Officers Association (GFOA) of the United States and Canada has recognized several West Virginia state agencies for their excellence in financial reporting.

The Certificate of Achievement for Excellence in Financial Reporting was awarded to the Consolidated Public Retirement Board (CPRB), the Board of Risk and Insurance Management (BRIM), the Finance Division of the Department of Administration and the Lottery Commission, based on these agencies' Comprehensive Annual Financial Reports (CAFR) for the fiscal year ending June 30, 2015. In making this prestigious national award, GFOA recognizes conformance with the highest standard for preparation of state and local government financial reports. According to GFOA, the Certificate of Achievement is the highest form of recognition in the area of governmental accounting and financial reporting, and its attainment represents a significant accomplishment by a government and its management.

This is the 21st year of receiving this honor for BRIM and the Finance Division; the 19th year for the Lottery Commission; and the 4th year for CPRB. The CAFR is judged by an impartial panel to meet the high standards of the program, including demonstrating a constructive "spirit of full disclosure" to clearly communicate its financial story and motivate potential users to read the CAFR.

The GFOA is a major professional association servicing the needs of more than 18,000 appointed and elected local, state and provincial-level government officials and other finance practitioners. It provides top quality publications, training programs, services and products designed to enhance the skills and performance of those responsible for government finance policy and management.

Mandatory High-Level Officials Training Now Online

A recording of the State Officials' Purchasing Procedures and Purchasing Card training conducted on November 9, 2016, is now available online.

Co-presented bi-annually by the West Virginia Purchasing Division and the West Virginia State Auditor's Office, the content of this training is updated each year to reflect the most up-to-date purchasing rules and regulations, as well as any changes in the law.

This fall, the training was conducted via WebEx for the first time. Among the benefits of WebEx is that it allows users to listen to the webinar via computer instead of by phone. There is also a WebEx app available for those who choose to partici-

pate using a mobile device.

This training is required for the state's high-level officials and is conducted twice each year, in accordance with West Virginia Code §5A-3-60. This law requires all high-level state officials including "executive department cabinet secretaries, commissioners, deputy commissioners, assistant commissioners, directors, and their deputies and assistants, deputy directors, assistant directors, department heads, deputy department heads, and assistant department heads" to complete two hours of training annually on purchasing procedures and purchasing card processes. Designated procurement officers are prohibited from attending unless they hold one of the aforementioned titles.

Watching the training online will suffice to meet this requirement. To view the recording, visit www.state.wv.us/admin/purchase/training/mandatory.html.
