Gov. Jim Justice Delivers Annual State of the State

On January 8, 2019, Gov. Jim Justice delivered the annual State of the State at the West Virginia Capitol. During his address, Gov. Justice recognized the state's largest six-month surplus and his desire to focus on education, the opioid addiction and job investments in West Virginia.

In addition to wanting to improve the education of our children, Gov. Justice also sees focusing on education as a way to combat the harmful stereotypes and misperceptions facing West Virginia. He challenged the Department of Education to improve the state's math scores, reduce student absenteeism, revisit the state aid formula and strive to become the first state to offer computer science classes in every high school

Capitol Campus Trees Donated to Fish Habitat Project

The two Christmas trees that were displayed on the Capitol Campus during the holiday season are now giving fish a place to live and thrive. The West Virginia Department of Environmental Protection, West Virginia State Parks, and the West Virginia Division of Natural Resources (DNR) partnered with Charleston's Capitol Market to collect Christmas trees to be repurposed as fish habitats in lakes across the state.

A crew from the General Services Division (GSD) cut the Capitol Campus holiday trees in half and donated the top halves of each tree to the project. This made it easier to transport the trees from the Capitol Market to the lakes.

"This is a great way to recycle trees that otherwise would end up in landfills," said Grounds Manager John Cummings. "We're happy to do our part."

The trees provide cover for small, young fish and ambush spots for larger, more predatory fish. DNR officials have found bluegills, crappie, bass — just about every species that prefers woody cover — at these tree sites.

In the past, DNR workers simply tied the trees to cinder blocks and tossed them into the water, but they found that when water levels were down and the trees exposed, people would cut them loose and use them for firewood.

This year, they tried a different approach. They trimmed off some of the lower limbs, slid the trunk through the hole of a cinder block, then nailed a piece of treated wood onto the stump to hold everything in place. Not only will the new arrangement make the trees more secure, it will have the added benefit of allowing the trees to stand upright after

they're sunk, which should make them even more attractive to the fish.

The donated trees will be used as fish habitats in Beech Fork Lake, Big Ditch Lake, Burnsville Lake, Cheat Lake, East Lynn Lake, Plum Orchard Lake, Stonecoal Lake, and Stonewall Jackson Lake.

Important Driving Tips to Stay Safe on Winter Roads

Severe weather can be daunting when traveling by car. The Fleet Management Division (FMD) would like to share some tips to keep you and your fellow drivers safe this winter season:

WINTER DRIVING TIPS:

- Make sure your tires are properly inflated.
- Keep your gas tank at least half full to avoid gas line freeze-up.
- Do not use cruise control when driving on a slippery surface.
- If the car is sliding on ice, turn your front wheels in the same direction that the rear of the vehicle is sliding. For example, if the back of your car slides to the right, turn the wheel to the right.
- Accelerate and decelerate slowly. Applying the gas slowly to accelerate is the best method for regaining traction and avoiding skids. Don't accelerate too quickly and be sure to take extra time to slow down at stoplights.
- The normal dry pavement following distance of three to four seconds should be increased to eight to ten seconds. This increased margin of safety will provide the longer distance needed if you must stop.
- Don't stop if you can avoid it. There's a big difference in the amount of inertia it takes to start

- moving from a full stop versus how much it takes to get moving while still rolling.
- Don't power up hills. Try to get a little inertia going before you reach the hill and let that inertia carry you to the top. As you reach the crest of the hill, reduce your speed and proceed downhill as slowly as possible.

IF YOU BECOME SNOWBOUND:

- Stay with your vehicle. It provides temporary shelter and makes it easier for rescuers to locate you. Don't try to walk in a severe storm. It's easy to lose sight of your vehicle in blowing snow and become lost.
- Avoid overexerting yourself if you try to push or dig your vehicle out of the snow.
- Tie a brightly colored cloth to the antenna or place a cloth at the top of a rolled-up window to signal distress. At night, keep the dome light on if possible. It only uses a small amount of electricity and will make it easier for rescuers to find you.
- Make sure the exhaust pipe isn't clogged with snow or ice. A blocked exhaust could cause deadly carbon monoxide gas to leak into the passenger compartment with the en-

- gine running.
- Use whatever is available to insulate your body from the cold. This could include floor mats, newspapers and/or paper maps.

Fleet Announces Updated Rental Rates

The Fleet Management Division (FMD) would like to inform state employees of its new daily vehicle rental rates, which were announced in January. Although there was a slight increase in the rates due to increased maintenance and fuel costs, these rental vehicles provide a good option for state employees traveling for state business.

The daily rates offered by FMD include mileage and fuel costs that are incurred through the use of its ARI fuel cards. Rentals are available for daily and long-term use. FMD also offers E-ZPass transponders upon request.



PEIA Adopts HealthCare Plan for Fiscal Year 2020

On December 20, 2018, the Public Employees Insurance Agency (PEIA) Finance Board met to discuss and adopt the financial plan for Fiscal Year 2020. The plan adopted at this meeting will go into effect on July 1, 2019.

The plan will eliminate penalties



originally intended to encourage members to seek in-state care, including a 10 percent higher coinsurance rate, a \$25 per visit copay, and a facilities fee limit that requires members to pay the difference between discounted in-state rates and higher out-of-state and out-

of-network rates for a variety of routine procedures such as lab tests, MRIs and colonoscopies. The coinsurance change applies only to counties bordering West Virginia. The higher coinsurance rate will remain in place for out-of-state providers beyond the bordering counties.

The plan also adds an appeals process for members who require medications on the Tier 3 nonpreferred brand name

list, which carries a 75 percent coinsurance rate up to the \$1,750 annual outof-pocket maximum for prescription drugs.

Finally, the plan suspends the Healthy Tomorrows bloodwork and reporting requirements while the staff makes plans for the next phase of the program. No action is required between now and May 15, 2019, for policyholders who have not submitted a form. Additionally, PEIA will destroy any forms that have already been submitted. The annual physical and screening benefit will remain in place. Members are encouraged to check their Summary Plan Description for details.



BRIM Hosts Annual Privacy Day Event to Help Prepare State Agencies for Cyber Threats and Attacks



To recognize the importance of cyber threat preparedness, Gov. Justice proclaimed January 28, 2019, as Cyber Security Awareness and Data Privacy Day in West Virginia. To assist state agencies in preparing for such threats, the West Virginia State Privacy Office within the Board of Risk and Insurance Management (BRIM) conducted an event to educate state agencies on the risks they currently face and best practices to avoid those risks. During the event, BRIM promoted the Privacy Program's ability to handle threats, as well as provide an opportunity for agencies to learn how to prepare for an unexpected cyberattack. January 28th is recognized internationally as Data Privacy Day.

West Virginia's Cyber Breach Coach, Scott Koller from BakerHostetler, conducted tabletop exercises involving phishing and ransomware scenarios to give attendees an interactive experience. Koller's practice is centered on privacy and security compliance matters and data breach response. He has helped hundreds of clients through incident response and data breach investigations involving malware, network intrusion, inadvertent disclosure of information, and ransomware.

Mary Jane Pickens, director of BRIM, stated, "We believe that responsibly and proactively managing the risk around cyber security will promote a safer environment in which our citizens and businesses function. Meaningful steps are needed to ensure that state technology systems operate properly, and that citizens and businesses can interact and share information with state agencies knowing that cyber security is front and center."

The State Privacy Office serves the citizens of the state by managing the privacy protection of personally identifiable information collected and maintained by Executive Branch agencies. Tips on how to prevent a security breach can be found at http://privacy.wv.gov/tips.

statewide. Gov. Justice also requested that the Promise scholarship be modified to include vocational education.

"We have got to refocus ourselves on our youth and some way steer them away from this horrible drug epidemic and help them become a workforce that we've got to have in West Virginia," said Gov. Justice as he called for \$5 million in his budget to expand the Communities in Schools program.

A new program, known as Jim's Dream, was also introduced with the goal of helping individuals avoid drugs and increase employment. Gov. Justice requested \$5 million be invested toward prevention with another \$10 million to support treatment and training, including staffing and maintenance of equipment at vocational centers. Justice would like to see addicts who complete a detox treatment program and earn a certificate through a vocational school be allowed to petition the court to have any drug misdemeanors expunged from their record. This program

would also increase the eligible workforce in West Virginia.

Other initiatives and achievements addressed during his presentation included the investment of \$150 million into PEIA; praise for the work going into West Virginia's state parks; the success of the Roads to Prosperity program; recognition of "superstar" General Hoyer for his work with the National Guard, the more than 90% graduation rate of the Mountaineer Challenge Academy and the RISE program; no new taxes and the promise of "significant tax cuts"; and a 40% reduction of overdoses in Cabell County.

"I meant it when I said over and over and over that all I've ever really wanted for this state is goodness, and its people. That's all I want," concluded Gov. Justice.
