DOP Class Focuses on All Aspects of Navigating Change

The one thing in life that is constant is change. But when studies show that 95 percent of all New Year's resolutions are broken – most within weeks - and approximately 70 percent of organizational change initiatives fail, the question then becomes how can we successfully facilitate organizational change?

That is the problem addressed in "Managing for Excellence III: Beyond Boundaries," a course being offered by the Division of Personnel's Organization and Human Resource Development (OHRD)office. Under OHRD's leadership, this four-day program is the capstone course for the Center for Quality Government.

Most change initiatives are doomed from the beginning because they run counter to what is known about human behavior, said Senior Development Consultant Mark Isabella. "The two strategies most often used in change are force and hope, and neither have a very good track record," he said.

Instead, Isabella said, the most important aspect of change,

and the most overlooked, is planning. "That is the step most often ignored because we believe change is going to be easy," he said. The key, them, is committing to a good plan and the ability to implement it. However, communication is another element that is frequently overlooked. "In most efforts, organizational changes are planned behind closed doors, revealed suddenly with little or no communication. Often the message fails to convey the urgency or necessity for the change," Isabella said. "But for the change to succeed, you must give stakeholders a voice in the change, as well as provide the resources and tools for change. When stakeholders have true engagement, then they are committed to the change."

Isabella said the course is designed to help managers plan, lead, implement, and manage change. "Leaders are ultimately

Purchasing Division Ventures Into Cyberspace for Training

The Purchasing Division ventured into cyberspace to enhance its in-house training programs by successfully performing its first-ever statewide webinar in April.

Purchasing officials were able to reach more than 35 procurement officials from all corners of the state via the webinar. Buyer Supervisor Chuck Bowman conducted training on Request for Quotations while Staff Development Specialist Samantha Knapp organized the webinar and Purchasing Applications Specialist Mark Totten handled its logistics. Attendees of the webinar were able to follow an online presentation while listening to Bowman present it live via MeetingPlace, a web-based teleconference software program offered through the Office of Technology. Participants could submit questions online during the webinar or ask them by conference call at designated times.

"For this to be our first attempt in offering a webinar, we were very pleased with the results. We have received a great deal of positive feedback from the participants and are ready to go forward with a second webinar scheduled later this summer," said Purchasing Director Dave Tincher. "We will make slight modifications based on feedback from participants, but envision this to be another useful training component from our agency in the future."

During the last several years, the Purchasing Division has greatly increased its training by offering programs yearround in addition to its annual statewide Agency Purchasing Conference.

In September 2009, the Purchasing Division announced the creation of its Procurement Certification Program. To allow procurement officials greater flexibility in earning credits toward certification, Purchasing has placed six online training modules on its website in addition to monthly in-house training sessions at the Capitol, and now webinars.

Privacy Tip of the Month

The State Privacy Office of the West Virginia Health Care Authority shares a Privacy Tip each month with our department employees. Please take note of this valuable information which may protect you and your family.

What's Your Question?

I've been making an effort to review Privacy Policies and there's something I need a bit of clarification on. Can you give me little more information on Individual Redress?

Here's the Answer!

The Individual Rights Policy requires each Department to provide "an appropriate means of individual redress." This policy may be found at *http://www.privacy. wv.gov/privacypolicies/Pages/default.aspx.*

This means that each Department must have a formal process for handling privacy-related questions and complaints. The policy requires the process to be easily accessible and simple to use.

Everyone has a right to understand the Department's privacy and security practices. Everyone also has a right to ask questions about and raise objections to the collection and use of personally identifiable information (PII), such as home address, telephone number and driver's license number.

Never discourage a person from asking a question or making a complaint. If someone has a question about your Department's privacy practices, you can provide the person with a copy of the applicable Privacy Notice.

You should refer all other privacy questions – as well as all complaints – to your Privacy Officer immediately. See Page 5 for a list of privacy officers for each of our agencies within the department.

Miller Named Privacy Officer for Department of Administration

Miller said employees suspecting a potential breach of privacy should first contact their agency privacy officer to ensure "a small problem does not become a large problem." Yet, he said, Tom Miller was named privacy officer for the Department of Administration after initially serving as privacy officer for both the Public Employees Insurance Agency and the West Virginia Children's Health Insurance Program.

aerial searches."

Wood gave several examples of how the State Police Section of the Aviation Division was an integral part of such missions during recent months. Larry Copley, pilot and rotary wing supervisor at the Aviation Division, was dispatched to Fayette County to assist in the search and rescue of a missing woman in the New River Gorge area. It was Copley and

a Fayette County Sheriff deputy as his passenger in the state helicopter who located the woman who tragically perished while lost and coordinated the recovery crew to the site.

Sgt. Shawn Coleman, pilot for the State Police Aviation unit and James Perkins, pilot/mechanic at the Aviation Division, located a missing hiker in Greenbrier County. Perkins was able to spot the missing person by using night vision goggles and with the helicopter search light and communication capabilities, coordinated search crews on the ground to the hiker to facilitate the rescue.

Perhaps one of the more notable law enforcement assignments of recent months came when Sgt. Coleman and Perkins were dispatched to Mercer County to search for a fugitive wanted in Ohio on a murder and disappearance charges. The two used the helicopter to conduct an aerial search of the wooded area where the suspect was believed to have been hiding after his stolen vehicle was located in Princeton. Within 10 minutes after the search began and by utilizing both spotters and the helicopter's infrared camera system, the suspect was flushed from his hiding spot.

Perkins saw the suspect hiding behind a tree looking at a state trooper who was running in his direction. The helicopter was then positioned directly

over top the suspect at which point he was apprehended by a state police canine unit.

"These three instances exemplify the dedication of the Aviation Division's staff to provide continuous safe, reliable, professional and accident-free air transportation for the good of the state," Wood said. "Our staff does this on a 24/7 basis in all types of weather across our mountainous terrain. I think one would be hard-pressed to find a more-efficient or safer aviation staff than the one we have."

The Aviation Division unveiled its new website in May, giving visitors a more user-friendly means to find information about the agency. The new site was constructed in conjunction with West Virginia Interactive, a state contractor for web design services.
