PEIA Reminds Members to Make Changes during Open Enrollment

Open enrollment for the Public Employees Insurance Agency (PEIA) health plans began April 2, 2017, and ends May 15. During the open enrollment period, eligible employees can make changes to their health plan including adding, dropping or changing coverage for themselves or their dependents. Changes can also be made to the Mountaineer Flexible Benefits program.

PEIA distributed the Shopper's Guide in late March to all current policyholders. The Shopper's Guide offers information regarding the different types of coverage offered, including the PEIA PPB Plans and The Health Plan's HMOs and PPO. Women's History Month Celebrated at Capitol in March

March meant girl power at the Capitol during several events to celebrate Women's History Month.

The Division of Personnel (DOP) scheduled Governor's School for the Arts students to sing and play music written by West Virginia women during an event on March 8, 2017, in the Governor's Reception Room. First Lady Cathy Justice spoke to the group in her first solo appearance.

The DOP also helped sponsor the 2017 Women's and Girls' Day at the Legislature on March 27, 2017. The annual event's motto is "to lead, achieve and govern." The group spent the morning hearing from Department of Education and the Arts Secretary Gayle Manchin, touring the Capitol, visiting legislators and attending sessions in the House and Senate. Lunch was held at the Culture Center, which was followed by a program on giving back to local communities and developing a personal strategy for the future.

Models and nonprofit motivational speakers Erin and Leah Eliopulos addressed topics including diversity, anti-bullying and safety issues, politics, participation, community leadership, education, and economic empowerment. The day was a unique experience where women and girls learned together to lead, govern and have a voice in their communities.

"They also learned that although there are a lot of issues before them that need to improve, to remember that our current condition does not define us, or anyone," said Julie Palas, Interim Executive Director of the West Virginia Women's Commission. "We can do more. There is always one more move we can make, one more action we can take. Maybe others have tried to make improvements in the past using different tactics, but maybe they

will have that one new idea that can make a difference now. And if they choose, they can run for office themselves and have an even greater impact on issues relating to women and families in West Virginia."

Women and girls who participated in this event were encouraged to take talking points and recommendations developed during the day back to their schools and organizations.

Registration Changes Begin May 15 for Instructor-Led Workshops

Beginning May 15, 2017, registration for instructor-led workshops scheduled for July 1 or later will be made through the state's Learning Center at *www.onlinelearning.wv.gov*.

The Division of Personnel (DOP) and Office of Technology (OT) will be moving registration for these courses from the current Conference and Education Reg-



istration site (GoSignMeUp) to the state's Learning Center. While online courses have used the Learning Center for years, this move for instructor-led courses will consolidate all registration activity into one system and allow DOP and OT more opportunities to offer blended learning, or a combination of online and in-person training.

Students who have logged into this site previously will need to use their unique User ID and Password to enter the Learning Center. Those who have not logged in recently should have a default password of "password." Students may click on the Forgot Your User ID or Password options to receive their login information.

All courses, both instructor-led and online, will be available in the Course Catalog for registration.

Training Now Offered on Adobe Acrobat XI Pro



Mason County Student Selected as Winner in National Poster Contest

The Office of Technology (OT) is extremely pleased to announce that West Virginia student Melanie Smith has been selected as a winner in the 2017 Kids Online Safe Poster Contest. Smith, a 12th grader from Mason County, was one of thirteen entries selected in the contest. Each of the winner's art will appear in a 2018 calendar that is distributed nationally as part of National Cyber Security Awareness Month in October.

The Kids Online Safe Poster Contest is hosted each year by the Center for Internet Security, a national nonprofit dedicated to improving cyber security in the public and private sectors. Thousands of students from across the nation participated in the contest, which was open to public, private and home-schooled students in grades K-12. The artwork and messages focused on themes such as preventing cyber bullying, practicing good cyber ethics, staying safe on social networking sites, and protecting against worms and viruses.

Each year in West Virginia, the state-level part of the contest increases, and OT is thrilled to have so many students and schools involved. The creativity and imagination displayed in the entries speak volumes about the talent and cyber-awareness of West Virginia children. The

Purchasing Director Dave Tincher Retires After Many Years of Service

After serving nearly 40 years in various procurement capacities, Purchasing Division Director David Tincher retired on April 30, 2017.

During his tenure, he realized many accomplishments, including the transition from commodity-based to agency-based buying assignments to enhance procurement relationships between the Purchasing Division and state agencies; a vast expansion of the procurement training program; the creation of a statewide procurement certification program that is recognized by the Division of Personnel; and the achievement of the National Procurement Institute's Excellence in Procurement award for four consecutive years.

Additionally, he testified regularly in legislative hearings as the leading public purchasing authority in West Virginia to create and change laws, where appropriate; directed the Surplus Property Program that affected the acquisition and sale of federal and state surplus property and was also instrumental in constructing the new surplus property office and warehouse facility late last year; managed the state business travel program for all state employees required to travel as part of their job; and served on various committees and boards for the National Association of State Procurement Officials.

During the earlier years of his ten-

PEIA also reminds PPB Plan members to complete their Healthy Tomorrows paperwork. *Healthy Tomorrows* is an initiative to make active employees and non-Medicare retirees aware of their modifiable risk factors, and to encourage them to be healthier. Members must show that their blood pressure, blood glucose and cholesterol levels are within an acceptable range or have a certification from a physician that those numbers cannot be met. The *Healthy Tomorrows* initiative applies only to the policyholder, not to any enrolled dependents.

To make changes, visit *www.wvpeia. com* and click on the green Manage My Benefits button. Open enrollment changes for Plan Year 2018 will go into effect on July 1, 2017.

The West Virginia Public Employees Insurance Agency (PEIA) is pleased to offer a new money-saving service to its members. Rx Savings Solu*tions* is an innovative program that will analyze prescription data and inform PEIA members how they can save money on their prescriptions.

Rx Savings Solutions is a free service that provides clear cost comparisons among prescriptions with easy-to-understand healthcare terms. Members can be notified of this information by phone, email or text message and have access to support from certified pharmacy technicians.

The information gathered by this service is personalized to each member's medications, as well as the medications of his or her family and dependents.

With the user experience being HIPAA-compliant, all PEIA PPB plan members are eligible, even if they are not currently taking prescription medications.
