General Services Introduces New Online Flag Request Process

Holidays such as Memorial Day and Independence Day are coming up soon, and members of the public, including veterans, who wish to display a flag for these celebrations can request one that has flown over the state Capitol building.

Requests for a flag are usually made for a specific purpose, such as to honor a veteran, mark an anniversary, or to mark some other special occasion. Historically, those requests were made by calling the General Services Division (GSD) directly. Now, an online form has made that process easier.

The public may access this form online through the Department of Administration's website at *https://administration.wv.gov* or by clicking on the Flag Request Form *here*.

The flag you receive will be accompanied by a certificate with the date it was flown over the Capitol.

The agency is working on additional upgrades to the process.

Adventure Awaits Across the Mountain State

Whether you have 30 minutes or a full week, West Virginia is full of things to see and do this spring and beyond.

Wildflowers at Canaan Valley Resort State Park

In late April and early May, Canaan Valley's frigid landscape transforms into fields of blooms. A few flowers to look for include red trilliums and milkweed, which can be on the Monarch Trail.

But spring isn't the only time to see beautiful flowers and foliage in Canaan, according to the Tucker County Visitors Bureau. In the summer, look for pink rosebay rhododendron, purple shriver's frilly orchid, and yellow Blue Ridge St. Johns-wort.

Summersville Lake

West Virginia's newest state park is also the state's largest lake, and depending on what time of year you go, you could have very different experiences. In the summer, the lake that is nicknamed the "Little Bahamas of the East" is perfect for boating, swimming, and other warm weather activities.

After the lake is partially drained during Gauley season, the exposed rocks from the receded water creates a great place for rock climbing, and you might even get to see the underwater ruins of the town of Gad, which turned into "West Virginia's Atlantis" when the Summersville Dam was built.

Starry Skies over Spruce Knob

Spruce Knob is the highest peak in West Virginia and is also known to be one of the best stargazing spots in the state. The whole Spruce Knob-Seneca Rocks National Recreation Area includes 100,000 acres, so you'll be able to find a perfect spot to see the sky, whether you're on the Spruce Knob Observation Tower or in your own corner of the woods.

Although it is remote, the tower is accessible by car, and from the top, panoramic views of the sky can be seen above some of the highest peaks in West Virginia.

New River Gorge

New River Gorge National Park & Preserve is the only national park in West Virginia and includes more than 72,000 acres and 53 miles of the New River, meaning the opportunities for outdoor recreation are endless. From high-adrenaline adventures like whitewater rafting and rock climbing to relaxing outdoor activities like hiking and historical sightseeing, the New River Gorge has it all.

If you aren't sure where to start, the National Park Service has an online guide to help plan your visit. Visitors can also check out the nearby Hawks Nest State Park for more incredible views.

Hatfield-McCoy Trails

The Hatfield-McCoy trail network has more than 1,000 miles of off-roading for ATVs and UTVs. The network is the largest on the East Coast and is a great way to experience West Virginia's landscape and some of the welcoming towns in the southern half of the state. Although the trails are intended for ATVs, they are also open to hikers and mountain bikers. Trail passes can be purchased at more than a dozen trail-head facilities or at any of the hundreds of vendor locations across the region.

While in the area, learn about the history of the Hatfields and the Mc-Coys, one of the most famous family clan rivalries in history that took place along West Virginia's river border with Kentucky.

WVSASP Hosts Open House for Nonprofits, Eligible Organizations



The West Virginia State Agency for Surplus Property (WVSASP) is inviting organizations from across the state to attend its Open House for Eligible Organizations, scheduled for May 14, 2025. This event is open to nonprofits, local municipalities, state agencies and other eligible organizations, such as churches, school boards, and volunteer fire departments.

"WVSASP has the unique ability to help connect eligible organizations with assets they need at a great price," said Manager Jessica Burns-Mc-Donnell. "From office furniture and cleaning supplies to planes and vehicles, the state and federal property programs

are a great resource for eligible organizations looking to make the most of their budget."

During the open house event, organizations will have the opportunity to tour the warehouse, meet the staff, and learn about the programs and services WVSASP offers. Light refreshments will also be offered.

"We are looking forward to being able to connect face-toface with eligible organizations," added Burns-McDonnell. "Whether they are familiar with WVSASP or just learning about us for the first time, I invite all interested organizations to come see what we are all about."

WVSASP will present two informational sessions on its state and federal surplus property programs at 10:30 a.m. and 12:30 p.m. on the day of the event. Assistance will also be provided for any eligible organization wishing to complete or update its *Application for Eligibility* on file to participate in these programs. House Resolution Changes Public Hearings for Bills

The Legislative session wraps up this month, and the new process for moving bills through the West Virginia House of Delegates has added an extra layer of due diligence.

The House approved a new rule for the chamber for this session, which ended the requirement for public hearings for bills when they are requested.

House Resolution 1, completed in February, allows a committee's chairman or vice chairman to invite members of the public to testify on bills as they are being considered in committees. Those who cannot make it in person, according to the rules, can submit testimony in writing, which will be distributed to members of the committee.

Bills are now considered over two days in committees, with public comments submitted and given on the first day.

As the session winds down, individuals can easily track bills that are of interest to them by visiting the Legislature's website at *www.wvlegislature.gov* and clicking on the Bill Status option at the top of the page. A dropdown menu offers two options: Bill Status or Bill Tracking. Choosing Bill Status allows users to view all bills introduced in each chamber or to search for them by number, subject, short title, sponsor, or date introduced. Bill Tracking requires the user to set up an account with a username and password. Then, by clicking on the Add Bills/Lists tab, the user can create multiple lists with unique names and add bills accordingly. To check the progress of bills on each list, the user simply needs to click on the My List tab under Bill Tracking, and click on the list name. The latest activity for each bill will populate.

Anyone needing technical assistance can click the Contact tab on the home page.

Registration Now Open for Spring 2025 Mandatory High-Level Officials Training


Registration is now open for the State Officials' Purchasing Procedures and Purchasing Card Rules training, co-presented by the West Virginia Purchasing Division and the State Auditor's Office. This two-hour session, scheduled for Thursday, May 8, 2025, will be conducted online as a webinar from 9 a.m. to 11 a.m.

Offered twice per year, this training is mandatory for high-level state officials as indicated in W.Va. Code § 5A-3-60. The code requires all high-level state officials to annually complete two hours of training on purchasing procedures and purchasing card processes. Information on how to register for this live online training can be found on the Purchasing Division's website at <code>https://www.state.wv.us/admin/purchase/training/mandatory.html</code>. The webinar will be recorded and posted within CourseMill for later viewing. Instructions on how to view the recording can be found at the aforementioned link.

This training must be completed by June 30, 2025, to remain in compliance with state code. Anyone who attended the November 2024 webinar or viewed its recording has met the requirement for this fiscal year.

W.Va. Code § 5A-3-60 requires people in the following positions to complete two hours of training annually on state purchasing procedures and purchasing card rules:

- Executive department secretaries
- Commissioners, their deputies, and assistants
- Directors, their deputies, and assistants
- Department heads, their deputies, and assistants



Application Deadline Approaching for OHRD's Cohort Program

New supervisors and managers who have not taken the required courses in the Supervisor/Manager Training Program (DOP-P18) are eligible to apply for the Organization and Human Resource Development (OHRD) Cohort Program. Applicants accepted to the program will move through the required sessions as one group over the course of one calendar year. In addition, participants are eligible to receive one-on-one coaching and support from OHRD's Training and Development staff.

The Cohort Program was created to provide an opportunity for new state government managers/supervisors to quickly enhance their management knowledge and skills in an environment that fosters relationship building and facilitates completion of all DOP-P18 requirements within one year. In order to achieve these goals, it is imperative that each participant commit to and attend all sessions. OHRD staff will support attendance by checking in with participants and providing reminders for upcoming courses. However, if a participant is unable to attend/complete required courses within the specified time frames, that participant may be asked to leave the cohort and would be responsible for completing DOP-P18 requirements by registering in OHRD's regular program schedule.

Interested applicants must:

- Complete a Cohort Application Form here by May 30, 2025
- Make sure your supervisor received the Supervisor Support Form and submits a recommendation. Applications without supervisor support will not be considered.
