Employees Reminded of Inclement Weather Policy

Winter weather is just beginning, so employees should review the Division of Personnel's policy on inclement weather conditions (ES/IWC) if their agency does not have its own policy.

All state employees are expected to report to work as scheduled during ES/IWC unless otherwise instructed. If an employee cannot report to work due to weather and/or road conditions, he or she must use annual leave, accrued comp time, or an unpaid leave of absence. However, employees and their direct supervisor may establish a plan to allow for the employee to work from home or an alternate work location in place of the annual leave/comp time/leave of absence requirement. Employees may be able to make up time lost within the same workweek if they have approval to do so from their immediate supervisor. Comparable time off will not be provided to employees who choose to work as scheduled during an ES/IWC.

In situations where the workplace or office building is closed due to an ES/IWC, the agency head may direct employees to work from home, report to an alternate work location, or remain in restricted on-call status until the workplace is reopened. Employees should not be placed in restricted on-call status unless it is anticipated they will return to the normal work location during that scheduled workday.

The governor has final authority to provide personnel directives during an ES/IWC by proclamation or other orders. Please note that a "State of Emergency" does not necessarily mean your state office is closed. Contact your supervisor to see if your workplace or office is affected.

Cherry Blossom Trees Planted at Governor's Mansion

Gov. Patrick Morrisey and First Lady Denise Morrisey recently joined the Charleston Municipal Beautification Commission in planting six cherry blossom trees at the Governor's Mansion.

The commission is planting flowering trees as part of its Appalachian Spring Project, which is an effort to plant 1,000 flowering trees throughout Charleston.

The cherry blossom trees are native to Japan and were a gift from the Japanese people to Washington, D.C. These trees came directly from the tidal basin in D.C.

The trees planted at the mansion are expected to bloom in April 2026.

Christmas Trees Displayed on Campus

Each year, the General Services Division beautifully decorates Christmas trees on the Capitol Complex, thanks to generous donations from West Virginia residents.

This year, both the North Stage tree and the tree on the South Plaza were donated by Al Tolliver, who owns and operates Crickmer Tree Farm in Danese, W.Va. Tolliver has donated many trees over the years to be displayed on the Capitol Complex. Both trees are Norway Spruce and were donated by Crickmer Farms on behalf of the West Virginia Christmas Tree Growers Association.

They were planted approximately 28 years ago in one of the farm's Christmas tree fields. They were dug and transplanted into the farm's general landscape eight years later.

An official lighting ceremony for the trees will be conducted during the annual Joyful Night celebration on Dec. 4, 2026 starting at 6 p.m.

Two 25-feet-tall Norway Spruce trees from Crickmer Farms in Danese arrived on the Capitol grounds on Nov. 17.



WVOT Reminds Users to Turn Off Transcription Following Meetings to Protect Sensitive Information

As part of an ongoing commitment to transparency, accessibility, and accurate record keeping, many agencies have incorporated automated transcription tools into virtual meetings. While these tools can be useful for documenting discussions, they also introduce significant privacy and information security risks if transcription remains active after a meeting concludes.

Please note the following important considerations:

- Risk of Unauthorized Recording: If transcription is not turned off promptly, it may capture informal, private conversations after the meeting concludes, raising privacy and ethical concerns.
- Sensitive Data Exposure: Transcripts may contain Personally Identifiable Information (PII) or internal deliberations. Leaving it active unnecessarily increases the risk of this sensitive data being stored, shared, or accessed improperly.
- Legal and Policy Violations: Recording or transcribing without proper control may violate state/federal privacy laws, as well as agency records management and information security policies.

All staff are reminded to adhere to the following steps to ensure only the meeting organizer receives the transcript and to protect information integrity:

- **Restrict Who Can Start Transcription** (Organizer Role):
 - On The meeting organizer must enable 'Host management' immediately upon joining the meeting. This ensures that only the host and co-hosts have the ability to start or stop the transcription.
 - On not assign co-hosts if you intend for only the organizer to receive the final transcript. Co-hosts will also receive a copy.
- Turn Off Transcription Promptly: Turn off or stop transcription immediately once the meeting officially ends.
- Post-Meeting Security Check: The transcript is automatically saved as a Google Doc in the organizer's Drive. The organizer must perform a manual security check to ensure access is restricted.
- **Secure Records:** Ensure transcripts are stored, shared, or deleted in accordance with the agency's records retention and information security policies.

Maintaining the integrity and confidentiality of agency information is everyone's responsibility. Please remain vigilant when using transcription features to ensure compliance and protect public trust.

West Virginia Tourism Office Launches "Almost Heaven" Brand Licensing Program

The West Virginia Department of Tourism has launched an Almost Heaven brand licensing program.

The program will allow the licensed use of its "West Virginia" logo, "WV" icon, the "Almost Heaven" and "Country Roads" scripts, and the popular wooden "Almost Heaven" swings on apparel, accessories, and specialty merchandise. The move is in response to growing demand from local artists and business owners who want to feature the brand.

The Almost Heaven campaign, introduced in 2018 and inspired by John Denver's "Take Me Home, Country Roads,"

has become one of the state's most successful tourism brands. It has been featured on billboards, bus wraps, digital displays, print campaigns, and television spots across the country.

West Virginia State Parks have sold official merchandise for years, but officials say the new licensing effort means even more products will be available statewide.

The program is expected to roll out in phases, with additional guidance for participating businesses coming in the weeks ahead.


