Department of Administration Joins in Mountaineer Mile Initiative with Lunchtime Walk

The Department of Administration is proud to participate in Gov. Patrick Morrisey's "Mountaineer Mile" initiative, a statewide campaign designed to promote physical activity and encourage healthier lifestyles among residents. This initiative, which is a great way to kick off the spring season, encourages all West Virginians to walk one mile each day as part of a broader effort to enhance wellness and improve health outcomes across the state.

Department of Administration employees officially launched their participation in the initiative on Wednesday, April 2, 2025, with nearly 70 employees joining the inaugural walk. Beginning at the fountain in the North Circle, the group completed a one-mile route around the Capitol Complex. Employees continued walking daily throughout the month during their regularly scheduled lunch breaks, weather permitting.

"Small steps lead to big changes," said Department of Ad-

ministration Cabinet Secretary Eric Householder. "I support Gov. Morrisey for leading this important initiative. I encourage all Department of Administration employees to join in and make walking a daily activity, one step at a time."

Walking is a simple yet effective way to improve an individual's overall health and well-being, offering benefits such as reduced risk of chronic diseases, improved cardiovascular health, and enhanced mental wellness. Even short walks at a brisk pace can yield significant health benefits, making it easy for individuals to incorporate physical activity into their busy schedules.

"It was inspiring to see so many employees step outside and take advantage of this beautiful day to participate. I encourage everyone to keep up the momentum," Householder said.

Dept. of Administration Secretary Receives Congressional Patriot Award for Public Service



West Virginia Department of Administration Cabinet Secretary Eric Householder has been awarded the Congressional Patriot Award in recognition of his longstanding commitment to public service, leadership, and selfless dedication to the people of West Virginia.

Householder received the award itself in April 2025, but the honor was formally acknowledged on the floor of the U.S. House of Representatives in 2024. Then-Congressman Alex Mooney praised Householder's 14 years of service in the West Virginia House of Delegates, including his most recent roles as House Majority Leader and chairman of the House Finance Committee.

"I rise today to honor my good friend Delegate Eric Householder as he retires from the West Virginia House of Delegates after 14 years of service," Congressman Mooney said during his floor speech. "With the help of Eric's leadership, West Virginians have less regulation, lower taxes, and educational freedom. I am proud to bestow upon Delegate Householder my Congressional Patriot Award for excellence, leadership, volunteerism, and self-lessness—virtues without which our Republic cannot thrive."

Secretary Householder was appointed to lead the Department of Administration on Jan. 13, 2025. In addition to his public service, Householder is a small business owner with deep roots in his community. He holds a bachelor's degree in economics from Shepherd College and an MBA from Frostburg State University.

"It is an incredible honor to receive the Congressional Patriot Award," said Secretary Householder. "I am humbled by the recognition and remain committed to serving the people of West Virginia in every capacity I can. While my time in the legislature has concluded, my dedication to advancing opportunity and prosperity for our state is far from over."

Wolfingbarger Appointed Director of PEIA

Gov. Patrick Morrisey appointed Brent Wolfingbarger as the new director of the Public Employees Insurance Agency, effective April 18, 2025. Wolfingbarger most recently served as a Senior Deputy Attorney General of West Virginia since 2020, where he provided executive leadership for the state's Medicaid Fraud Control Unit.

He previously served as the chief ethics prosecutor for the District of Columbia Board of Ethics and Government Accountability; worked for Chickasaw Nation Industries, Inc., where he oversaw its Payment Error Rate Measurement (PERM) Review Contract with the Centers for Medicare and Medicaid Services (CMS), measuring improper payments and producing error rates for all 50 states and D.C.; and served as the Medicaid Fraud Control Unit Director for the District of Columbia Office of the Inspector General.

A native of Belle, W.Va., Wolfing-barger graduated from DuPont High School and West Virginia University before receiving his law degree from the Washington and Lee University School of Law. He has practiced law in West Virginia for 31 years.

Health Screenings Provide Cash Back from Sun Life

Annual medical screenings can help save lives. But did you know it also can put money in your pocket?

Policyholders enrolled in a Supplemental Health Plan through Sun Life are eligible for a Preventive Screening Wellness Benefit, payable once each year, per covered person. The benefit helps promote important annual screenings like colonoscopies, mammograms, many types of blood tests, school sports exams and dental exams.

The Sun Life Supplemental Health Plan is part of PEIA's Mountaineer Flexible Benefits plan.

When you complete a screening and submit your claim, Sun Life will send you a \$50 check per Supplemental Health Plan you're enrolled in when your claim is received. That's up to \$150 if you have all three Supplemental Health coverages - Accident, Critical Illness, and Hospital Indemnity Insurance.

The payment is in addition to what your health insurance pays for screenings.

To submit a claim, log on to your Sun Life account at www. sunlife.com/account and select "Submit a Claim," or call 1-800-247-6875, select option 1, and then follow the prompts. You will need to provide your name, date of birth, Social Security number, date of exam, and type of exam.

The Preventive Screening Wellness Benefit also applies to preventive dental care like cleanings. If you enrolled in both Dental and Supplemental Health from Sun Life, you would receive a wellness check in the mail automatically – no claim filing required. Sun Life will process any Preventive Screening Wellness benefits you have available when they receive a claim from your dentist.

Reminder: PEIA Open Enrollment Deadline is Approaching—May 15

Department of Administration employees are reminded that the open enrollment period for health benefits for Plan Year 2026 ends on May 15, 2025. During open enrollment, you can change your health plan; add, drop, or change coverage for yourself and your dependents without a qualifying event; and make changes to your Mountaineer Flexible Benefits, if applicable.

To make changes to your benefits online, go to peia.wv.gov and click the green "Manage My Benefits" button. Online changes must be finalized no later than May 15, 2025. Enrolled members may also request a transfer form, or ask any other questions, by calling 1-877-676-5573. The Plan Year 2026 Benefit Guide is available online at https://peia.wv.gov/Forms-Downloads/Pages/Shopper%27s-Guides.aspx.

PEIA members should be aware of the following changes in the upcoming plan year:

- an increase in premiums for non-Medicare retirees (12%), active state employees (14%), and non-state employees (16%);
- an increase (40%) in deductibles and out-ofpocket minimums
- an increase in the spousal surcharge from \$147 a month to \$350 a month; and
- copay increases on some services.
