Lindsey Atkins, outreach officer and executive assistant with the Consolidated Public Retirement Board (CPRB), has been selected as the Department of Administration's *Employee of the Month* for November.

A state employee for seven years, Atkins' duties include providing outreach seminars around the state to inform CPRB members of the fundamentals of the 10 different retirement systems the agency administers. She also helps set up and coordinate large outreach events for the agency, such as the payroll clerk seminars. In addition, she assists Deputy Director Terasa Miller with agency needs that include monitoring and responding to the main CPRB email address, special projects related to legislative changes impacting the retirement systems, ordering and designing materials with agency logos, and scheduling

appointments.

"Lindsey listens and responds in a kind and helpful way. She is a hard worker and knows how to get things accomplished," said the co-worker who nominated her. "She is the public face for most of our agency since she is holding the seminars and webinars. She is always put together and just an all-around great person."

When she's not working, Atkins spends a lot of her free time traveling with her four children for various school activities. She is also the assistant cheerleading coach at John Adams Middle School.

Atkins will be joined by friends and co-workers at a special ceremony presented by Acting Cabinet Secretary John McHugh on Thursday, Nov. 7, 2024, at 2 p.m. at the CPRB offices in Kanawha City.

West Virginia Earns 'B+' in Digital States Survey

The Center for Digital Government (CDG) has announced the results of its 2024 Digital States Survey, a biennial evaluation of the information technology (IT) practices of all 50 states. West Virginia achieved an overall grade of "B+," up from the "B" it received in 2022. The state also received an Outstanding Achievement recognition for resilience.

Since its inception 27 years ago, this biennial e-survey has helped benchmark state government use of digital

Public Hearings Scheduled Around the State for Comments on PEIA Plan Year 2026

The Public Employees Insurance Agency (PEIA) is extending an invitation to all state employees to attend planned public hearings on the proposed financial plan for Fiscal Year 2026 (July 1, 2025, through June 30, 2026). Attendees will have the chance to discuss and provide comments on the plan. As in previous years, PEIA will host one virtual hearing and multiple in-person meetings.

All hearings will begin promptly at 6 p.m. Registration for the in-person sessions opens at 5 p.m. on the day of the hearing, and any individual who wants to speak must indicate so during registration.

The proposed plan will be available online at *peia.wv.gov* no later than Nov. 4, 2024. To view the changes, visit the News Center on PEIA's website. Applications for 2025 Cohort Program Due Dec. 2

New supervisors and managers who have not taken the required Supervisor/Manager Training Program Policy (DOP-P18) courses are eligible to apply for the Division of Personnel's (DOP) Cohort Program. Successful applicants move through the courses as one group over the course of one calendar year. In addition, participants are eligible to receive one-on-one coaching and support from the Organization and Human Resource Development's (OHRD) Training and Development staff.

To apply, follow these steps:

- 1. Complete a Cohort Application Form (Cohort 2025 Application Deadline: Dec. 2, 2024). As you complete your application in Google Forms, be sure to put your direct supervisor/manager's correct email address. This will ensure that your application successfully makes it to the next step (i.e. your supervisor's approval).
- 2. Make sure your direct supervisor receives and submits his/her approval of your application WITH comments of support so your application will be considered complete. This approval form will be submitted to your supervisor via email after you submit your application and will include instructions on how to correctly complete this step. Applications that do not have both supervisor approval AND comments of support will be returned to you to resubmit.

The Cohort Program was created to provide an opportunity for new state government managers/supervisors to quickly enhance their management practices in an environment that fosters relationship building and facilitates completion of all DOP-P18 requirements within one year.

technologies to improve service delivery, increase capacity, streamline operations, and reach policy goals. The survey assigns a letter grade based on quantifiable results.

The grade of "B+" reflects a state with technology leaders who use appropriate, consistent, and standard good government practices in all aspects of state operations, governance, and administration.

According to the survey results for West Virginia, "Enhancing the digital government experience for West Virginia residents is a central component of the state's IT work. To fully understand the digital experience residents encounter with state agencies, the West Virginia Office of Technology will examine that experience against key performance indicators such as error rates, cost per transaction and user satisfaction score, among others. The Division of Motor Vehicles has introduced digital vehicle registration cards, which allow residents to carry digital versions of their vehicle registration, and more than 7,000 residents have opted into the program. The digital registrations are held in digital wallet platforms on smartphones."


In addition, the survey highlighted the state Legislature's creation of the Select Committee on Artificial Intelligence to begin the process of educating elected and public officials about the impact and opportunities of AI.

On back-end IT progress, West Virginia has transitioned

its on-site mainframe system to a hosted network with full disaster recovery and backup abilities, the survey said.

In obtaining an Outstanding Achievement recognition for resilience, West Virginia was commended for the ability to maintain continuous technical and business operations during peak usage, disasters, and crisis conditions.
