PEIA Offers Open Enrollment for State Health Insurance Options

Feeling a Bit Forgetful?

Try these three steps to ensure that you do not forget newly learned skills or lessons:

- Try to spend an hour or two of study time for every hour you spend in class.
- Review the notes you took from the previous day before you head to class.
- Review your notes later in the day or in the evening to ensure the new information stays put.

- adapted from Penn State University, Mont Alto website. Open Enrollment for Plan Year 2002 is set for April 2 through May 4, 2001. This period allows Public Employees Insurance Agency members to change plans.

"Shopper's Guides and transfer forms have been mailed to all PEIA members," said PEIA Communications Manager Jan Long, "It's very important that members read the Shopper's Guides carefully due to substantial changes in Plan Year 2002." These changes include:

- A service area restriction requiring that members and their dependents must live in the service area of a plan they wish to join, or in a county next to the service area.
- The withdrawal of three plans currently offered, Optimum Choice HMO, MAMSI Life & Health PPO, and Carelink Plan A. Participants in the withdrawn plans will default to PEIA PPB at the end of Open Enrollment if they do not submit a transfer form choosing another plan.
- An across-the-board premium increase for the PEIA PPB Plan, except for those participants earning less than \$18,000 per year. On average, the cost increase is \$4 for single coverage; \$7.50 for employee and children; \$13.50 for family coverage; and \$8.50 for family with employee spouse.
- Fertility drugs will no longer be covered as of July 1, 2001, but those

currently using the benefit may continue their three cycles of covered treatment.

 Tobacco-free PEIA PPB Plan participants will receive a \$5 discount for single coverage and \$10 for family coverage under a new "Preferred Premium." The "Preferred Premium" affects only PEIA PPB Plan participants. To-

state does have a program that offers health care insurance for families who fall within 200% of the poverty income level."

Susie Salisbury, coordinator for the Children's Day at the Legislature event, could not agree more as to the importance of getting the word out on the WV CHIP. "Our main goal was to get as many child advocates as possible at the Capitol and bacco-free members must sign the affidavit on the transfer form to receive the Preferred Premium. To qualify for the Preferred Premium, all enrolled family members must have been tobacco-free for five months by July 1. PEIA will not accept affidavits throughout the plan year, but will offer the discount each year during open enrollment.

"This event also provided an outlet to inform people of the implementation and outreach of the West Virginia Children's Health Insurance Program. We wanted to focus on the eligibility changes that went into effect last year."

According to Joyce Stover, coordinator for the Women's Day at the Legislature, the focus of this event was to look at how legislation affects women and how their lives have changed as a result. The inclusion of WV CHIP was imperative due to the extent which the program has reached West Virginians.
