Included in the Budget is an across-the-board pay raise for state employees. Effective July 1, all eligible state employees' pay will increase by \$756 annually. You will notice this increase on your July 16 paycheck.

Bills Passed Affecting the Department During the 1999 Legislative Session

Other Bills Passed This Session

HB2293: Changes number to constitute two quorums for the Consolidated Public Retirement Board.

HB2307: Repeal of pilot apprenticeship program involving General Services.

HB2617: Deputy Sheriffs' Retirement Act technical connections, expanding the definition of covered employment.

SB 211: Relates to letters of credit by banks or State Treasurer as security for bonds by depositories of public funds.

Legislation also provided continuation of the following programs and divisions:

During the 1999 Legislative Session, many Bills concerning the Department of Administration were passed and signed into law by **Gov. Cecil H. Underwood**. Below are brief descriptions of some of these new laws:

HB2262: Permits the state to pay employees in lieu of working the 15 days when dismissal notices have been given.

HB3029: Lottery proceeds designated to the Morris Square Building fund will go to the Capitol dome and Capitol Improvement Fund for repair maintenance and preservation. [Became law without Governor's signature.]

SBI17: Requires that the State Building Code be followed on all buildings built with public funds. The roofs must be sloped to avoid collapse from snow or rain.

SB 242: Permits the sale of the Morris Square Building at a fair market value determined by the required two appraisals.

SB 272: Authorized the Department of Administration to develop Administrative Rules and to amend the rules on the Purchasing Card Program.

SB 351: State employees continue to accrue increment pay during absences due to work-related injuries.

SB 516: Changes procedure for applying regular interest to members' account in Public Employees Retirement Fund from fiscal year to calendar year.


SB 564: Allows the Investment Management Board to use a nationally recognized accounting firm to audit the performance return of the retirement plans, which are part of the Consolidated Pension Fund.

SB 666: Addresses design build issues. When bidding construction projects, the architect and the contractor may be combined into one con-

tract. A board will be created to assist in evaluating the award criteria for these projects.

SB677: The Purchasing Director may solicit bids for interstate air service for one year as a pilot program to be underwritten by the state.

SB 702: PEIA law was amended to add two new sections defining terms. The Finance Board membership was addressed as well as the annual financial plan. The Finance Board and actuary duties were realigned. It also provided criminal penalty for fraud but immunity for reporting fraud. This legislation authorized the PEIA Director to negotiate contracts with health care providers.



Open Enrollment Extends through May 21

PEIA's Open Enrollment Includes Changes to All Health Plans

The Public Employees Insurance Agency refers to this year's Open Enrollment as a "new day" for managed care and the PEIA Indemnity Plan. Many changes were made in how these plans are to be administered for Plan Year 2000. Below are highlights of these changes:

PEIA Plan

This plan is changing from an indemnity plan to a preferred provider benefit (PPB) plan. There will be both innetwork and out-of-network benefits under the PEIA PPB plan. The PPB plan is similar to a preferred provider organization plan (PPO), but is similar to the old PEIA Indemnity Plan. The PEIA PPO is made up of WV providers who accept PEIA's reimbursements and providers in BlueCross and BlueShield PPO for out-ofstate care.

Prescription Changes

The new prescription benefit management firm is providing PEIA with a for-



mulary, which is a list of prescription drugs that enable members to receive the largest discounts. Medications not on the formulary are still available, but at a higher copayment.

Managed Care Medical Benefit Changes

For Plan Year 2000, PEIA permitted the managed care

plans to offer their commercial benefit plans, which are offered to other (non-PEIA) customers. As a result, premiums in many cases have been reduced, varying from plan to plan.

Managed Care Prescription Changes

Several plans have added dollar limits to their benefits; many have also added closed formularies.

More Changes

Extended Open Enrollment: Due to the volume of changes, Open Enrollment was extended by three weeks. The deadline is May 21.



Change in Capitol Shuttle Schedule Announced

Effective March 29, the hours of operation for the State Capitol Complex shuttle re-



turned to the morning and evening schedule. During the 1999 Legislative Session, the shuttle service ran throughout the business day.

The *current* schedule is Monday through Friday, from 7:00 a.m. to 9:00 a.m. <u>and</u> from 3:35 p.m. to 5:15 p.m.

The shuttle does not operate on any state holiday. The morning shuttle departs Laidley Field, starting at 7:00 a.m., and serves each of the stops listed below at approximately every 10-15 minutes.

The Capitol Shuttle stops at the following locations:

- Division of Highways (Building 5-Piedmont Road Entrance)
- Building 6 Entrance (California Avenue)
- East Wing Entrance (California Avenue)

Grievance Board Responds to Annual Customer Survey

Since 1998, the Education and State Employees Grievance Board has distributed a customer survey to evaluate the performance of the agency. To discuss the results of this year's survey, the agency held a board meeting at its Charleston Office. The analysis showed an overall improvement from last year.

In discussing the purpose of the survey, **Grievance Board Director Ron Wright** stated, "when doing a customer survey, you need to listen to the results and find ways to tell people that you <u>did</u> listen and took action."

As a result of last year's survey, the agency's website was redesigned to include a list of frequently asked questions and pamphlets were created, containing such information

as office addresses and telephone numbers.

This year's survey analysis indicated the most frequent complaint related to the timeliness of decisions. To address this problem, the Board recently modified its process, which will shorten decision time up to four days.

Other concerns included transcript accuracy and timely transmittal of appealed records to Circuit Court. To address these issues, a sampling of transcripts has already begun and the appeal paragraph in final decisions has been changed to include the requirement that the appealing party must notify the Grievance Board by Certified Mail of the appeal. Due to its commitment to improving the grievance process, the Board plans to continue surveying its customers annually.

Procedures for Issuing Parking Tickets Clarified by Cabinet Secretary Markus

With hundreds of parking spaces at the State Capitol Complex, a hundred more could be added and it STILL wouldn't be enough. Visitors and employees alike often find creative ways to secure a place for their vehicles; however, with the assignment of spaces, they often find themselves with a little pink reminder once they return...a parking ticket.

Cabinet Secretary Joseph Markus has the responsibility of addressing the many complaints from parking ticket recipients. After spending hours each week reviewing various instances, he issued a memorandum to all branches within the State

Capitol Complex regarding the issuance and voidance of parking tickets. **Effective April 15**, the following procedures will be implemented:

EMF

Display of Parking Decals

Tickets will be issued to automobiles not displaying a proper decal and will not be voided.

Malfunctioning Parking Meters

A report of a broken meter must be made by the employee to a guard or department parking coordinator on the day the meter was used. The malfunction must be verified that day for a ticket to be voided.

Legislative, Judicial and Executive Branches

Representatives of these branches of government have assigned parking. If they choose to park at a meter and are ticketed, the tickets will not be voided.

Handicapped Parking: No tickets will be voided for unauthorized parking in a handicapped space.
