## The Willingness to Accept Change is Key to Zoeller's Work Philosophy

Stephen Zoeller recently joined the Department of Administration as its director of Central Services, a new position that encompasses a variety of services offered by our department.

Just as the department offers a broad mix of services to its customers, Zoeller sees a comparison in the variety of positions in his career that he believes will help him with many of the challenges he may face in the future.

Central Services oversees the Purchasing Division, General Services Division, Information Services and Communication Division, Aviation

Services and the State Leasing Office.

Zoeller's earlier experiences included working in construction, a factory and even being a physician assistant. More recently since moving to West Virginia from Kentucky in 1986, he served as the director of the County Commissioner's Association. In 1993, he joined the Kanawha County Commission as its county manager and, in 1999, joined the Kanawha County Parks and Recreation as its director.

"For this position, it is a good background, because in the Department of Administration we perform many different services," he said. "As county manager and director of parks, you have to be able to do everything since there weren't many people. You have to understand how everything works. It is very similar here."

Zoeller has his own philosophy on the qualities of a good manager. "A good manager is like the oil in a machine. The

#### **Time to Review Your W-4 Form**

The W-4 form tells payroll how much income tax to withhold from your paycheck. With the recent tax cut, the amount withheld might not reflect your personal tax situation. The new withholding tables will not cause a problem for most people when they file for 2003. Most will get larger refunds.

Those who may want more or less tax withheld are people who think they will owe money at the end of the year and those who previously asked that extra money be withheld.

Married couples should make sure that their withholdings are not too small, according to the American Payroll Association in San Antonio. cogs are there, and a good manager is the oil that keeps all the cogs from being welded together," he said. "If you don't change the oil, the machine doesn't run. I can't do the things we need done without everyone's help. But, it is my job to make things run better and smoother to help all the pieces flow better."

Since coming to state government, Zoeller has been impressed by the quality of the work force. "I think generally state employees get a bad rap," he said. "The reality is tax dollars do go to pay for state employees' salaries, but the public is definitely getting their money's worth."

Prior to taking on this role as Central Services director, his primary focuses have been on the State Capitol grounds, building projects and leasing, along with several projects under the direction of Acting Cabinet Secretary Tom Susman. "I'm still in the process of getting familiar with the department and understanding everyone's job and how things work," he said.

An area in particular in which he has been involved in is the leasing process. "The state is undertaking several building projects. I am working with General Services and the Leasing Office and taking a close look at the leasing procedures. Hopefully, we will be making some recommendations to the Legislature for some rule changes regarding leasing. There has been much groundwork done in this area, but I'll be working with them on what has been done as well as the building projects."

Zoeller views his greatest accomplishment in life is the ability to always adapt and change to a given situation. "It's more of an ability to take what comes my way and deal with it as creatively and positively as I can. That means I may have to change every day and be willing to do so."

He added that he realizes when working with people and trying to accomplish goals, that things happen more effectively when he is

# **Southern Governors' Association Meeting Held at Capitol**

For the first time in the 69year history of the Southern Governor's Association, the state capital was chosen as the site for this year's meeting, which was held September 21-23. According to Chip Slaven, director of Federal Policy and Intergovernmental Affairs for the Governor's Office and coordinator for this event, the last time this meeting was held in our state was in the 1960s at The Greenbrier.

As another first, Gov. Bob Wise is the first West Virginia governor to be chairperson of the association. "SGA consists of 18 governors, 16 states and two territories," said Slaven. Typically, about 10 governors attend this annual meeting, he added.

"The main purpose of this event is to provide an opportunity for the governors to discuss policy issues and projects that correlate to the south," he said. Governor Wise focused on higher education access, in respect to initiatives, including the Promise Scholarship, as well as technology, such as distance learning and digital and virtual libraries.

Other prestigious guests of the meeting included former Gov. Gaston Caperton as keynote speaker for the meeting's kickoff and writer Homer Hickam, who offered his remarks during a luncheon.

A great deal of preparation was required in planning this meeting. Because the State Capitol was being used for the meeting, in addition to the Clay Center and Embassy Suites, the General Services Division staff performed many tasks to *show off* the grounds to our southern state governors. "We really wanted people to see the Capitol and to realize how

beautiful and unique it is," Slaven said.

Grounds Manager Kenny Young and his staff put some finishing touches on the flowers on campus. Operations Manager Tim Lee and his crew stripped and waxed the marble floors and stairwells, pressure washed the concrete fountain area, and worked closely with the State Police to ensure appropriate levels of security was provided.

"This is a very high profile project and we want the governors to have a positive impression of our state and, especially, our Capitol," Lee said. Staff from several sections of General Services worked during the meeting to assist with a variety of needs.

Slaven said he admits that an ulterior motive in hosting this conference is to help *sell* the state. "We want other governors to be impressed with how we put on this meeting and for other people to look at West Virginia as a potential conference site, which is why the Division of Tourism and the city of Charleston were involved," he said. "We want to change the image people have of West Virginia." As Coordinator of the Southern Governors' Association Meeting, Chip Slaven spent the last six months preparing for this opportunity to showcase the State Capitol to governors of several southern states.

By logging onto www.wv.gov, West Virginians may access information about starting a business, searching for state employees and agencies, and locating tourism events and places of interest.

"Customer service always has been a main focus of my administration," Wise said. "I want to make doing business in West Virginia a little easier, and this e-portal will provide better access to information and resources."
