Signs of Surplus Savings are Apparent Throughout Preston County Workshop

If you ask Richard Weekly what he has acquired from the West Virginia State Agency for Surplus Property (WVSASP), he may find it difficult to remember *everything*. Usually, he answers that question, by giving a tour of the Preston County Sheltered Workshop, Community Rehabilitation Program facility, which displays a wide variety of his *surplus* treasures.

Weekly, who serves as chief executive officer of the Reedsville, WV, facility, is proud of his bargains and does not hesitate to show them off. Examples of the surplus savings are found in nearly every department:

- **Media Department:** furniture, heat sealers, paper cutters, exhaust fans, paper taping machines, brooms, mops, janitorial equipment;
- **Label Affixing Department:** Air compressor, air line, lighting fixtures, taping machines, wall lockers, janitorial equipment;
- **Wood Department:** Tools, including radial arm saws, table saws, routers, drill presses, hand saws, hand drills, air nail, air compressor with air hose, light fixtures, emergency lights, a lathe;
- **Steel Shop Department:** Tools, work tables, chairs, grinders, applet jacks, electrical panels,

smoke evacuation pump.

- **Outside Lot:** Truck loading dock.

Are you beginning to get the idea that Weekly likes to save money? Throughout the facility, the director and his staff benefit from using surplus equipment, supplies, and other items donated by other sources. Although saving money is important, Weekly

No More Gravel...

Surplus Property Paves Over 20,000 Square Yards of Space

If you haven't been to the West Virginia State Agency for Surplus Property (WVSASP) warehouse facility recently, perhaps you need to plan a trip soon.

In November, a major project to enhance the outside area was completed. Approximately 20,000 square yards of lot space was paved. "This was something that we have been trying to accomplish for many, many years," according to Ken Frye, WVSASP Manager.

The area paved, which is located in the rear portion of the facility, has been used to display heavy equipment, vehicles, and other weather-resistant property. "This area has always been a problem for us. In the summer time, it was very difficult to control the weeds that grew and it was swampy," Frye said. "We would park the equipment in that area and it would sink into the mud."

Understandably, customers did

not want to shop in this unpaved area; therefore, it simply hurt WVSASP's efforts to properly market this state and federal surplus property.

"Through revenues generated by selling state and federal property, we have essentially tried to save money in order to pay for this paving," Frye said. He predicts that the paybacks will be substantial. "In addition to improving our marketing efforts, it will enhance our ability to better serve our customers and save us money through lower maintenance costs," he said.

In the past, one full-time person was assigned responsibility for maintaining this area. Although WVSASP has spent many dollars over the years in gravel, this area was never satisfactory.

WVSASP is pleased with the feedback already received by our customers. "I think that our customers feel that it is a return on their tax money. Most of our customers feel that they are getting something back," Frye adds.

Defend Yourself Against the Winter Cold with a Variety of Surplus Generators

Winter...a time for snow, cold, and, unfortunately, power outages. No reason to worry, though, since the West Virginia State Agency for Surplus Property (WVSASP) has a wide variety of generators currently available at their warehouse facility.

Whether you are needing electric power to provide emergency communications or to operate a complete facility, such as a clinic, police department or fire department, WVSASP may be your best choice. The generators range from 2.5KW (2,500 watts) all the way up to 200KW (200,000 watts).

Most of these generators are diesel powered and have very low hours. Some are also trailer mounted, so that they may be used as mobile units.

In addition to the generators, the Federal Surplus Property

stresses the importance of quality and safety.

"I am confident that without the Surplus Property Program, we would not have succeeded and, secondly, would not enjoy the level of success that we currently enjoy," Weekly said. "The availability of tools and materials at a low price enables us to continue to provide the services of this workshop."

Although Reedsville is a bit of a distance from Dunbar, Weekly confesses that he never goes to the Charleston area without taking time to visit WVSASP.

Do You Know What You Signed... in the Terms and Conditions of Sale?

CERTIFICATIONS AND AGREEMENTS (INCLUDING TERMS, CONDITIONS, RESERVATIONS AND RESTRICTIONS)

(A) THE APPLICANT CERTIFIES THAT:

(1) It is a public agency; or a nonprofit educational or public health institution or organization, exempt from taxation under Section 501 of the Internal Revenue Code of 1954; within the meaning of Section 203 (j) of the Federal Property and Administration Services Act of 1949, as amended, and the regulations of the Administrator, General Services. (2) If a public agency, the property needed and will be used by the recipient for educational or promoting for the residents of a given political area one or more public purposes, or, if a nonprofit educational institution or organization, the property needed for and will be used by the sale or other distribution; or for permanent use outside the State, except with prior approval of the State Agency for Surplus Property. (3) Funds are available to pay all costs and charges incident to donation. (4) This transaction shall be subject to the nondiscrimination regulations governing the donation of surplus personal property issued under Title VI of the Civil Rights Act of 1964; Title VI, Section 606 of the Federal Property and Administrative Services Act of 1949, as amended, and Section 504 of the Vocational Rehabilitation Act of 1973, as amended.

If at any time, from the date it receives the property through the period(s) of time the conditions imposed remain in effect, any of the property listed is no longer suitable, usable, or further needed by the applicant for the purpose(s) for which acquired, the applicants shall promptly notify the State Agency for Surplus Property, and shall, as directed by the State Agency for Surplus Property, return the property to the State Agency for Surplus Property, release the property to another applicants or another State Agency for Surplus Property, a department or agency of the United States, sell or otherwise dispose of the property.

In each issue, a section of the Terms and Conditions will be highlighted for your reference.

Does your agency have a need for a "hummer"? Perhaps, we should start with explaining what exactly is a hummer.

The high mobility multi-purpose wheeled vehicle, commonly known as a "hummer" or "hummv" (pronounced *hum-vee*), was originally placed into use in the federal government in 1985. These vehicles replaced the old familiar jeep which had been widely used since World War II.

Now that we've clarified the definition of a "hummer", you may wonder what your agency would do with one. The hummers have several advantages over the jeep. Let's take a closer look...

- hummers have an increased ground clearance. This increase was achieved by a redesign which eliminated straight axles;
- hummers have a wider profile which decreases the likelihood of roll-over during sharp turns or negotiating rough terrain.

Need a *hummer*? The West Virginia State Agency for Surplus Property has two hummers available through the Federal Surplus Property Program.

These improvements came with a price...the cost of a new hummer is approximately \$50,000. WVSASP currently has two models available: one four-door hard top and a two

Public Sales: Private Citizens Can Also Reap the Surplus Savings from WVSASP

A big impact of the State Surplus Property Program is in the area of our public sales. Private citizens may visit our facility and place bids on items no longer needed within state government.

Our first goal is to market this property to our eligible organizations, such as public agencies and certain non-profit groups. However, if no interest from these organizations exists, WVSASP may offer state property to the public, who may purchase the property by either a sealed bid process or by general auction. Auctions are usually conducted

monthly; however, due to inclement weather, they may not be organized during a winter month.

Since the public does receive a direct benefit from our program, many of our customers have developed a sense of ownership of this agency. They often contribute ideas and make comments on how we can improve our operation.

Several years ago when we built a new state warehouse facility, we received immediate positive responses from our customers, the public and the eligible organizations. For the first time in the

history of this agency, they were able to shop in relative comfort, since the facility is now heated in the winter and well lit.

There have been many improvements made to our facility in recent months, including the new warehouse, a paving project, and security fencing. WVSASP Manager Eager to Spread the Word About Surplus Savings

Do you want to hear about the West Virginia State Agency for Surplus Property? Ken Frye, WVSASP Manager, just can't stop talking about the benefits of the State and Federal Surplus Property Program.

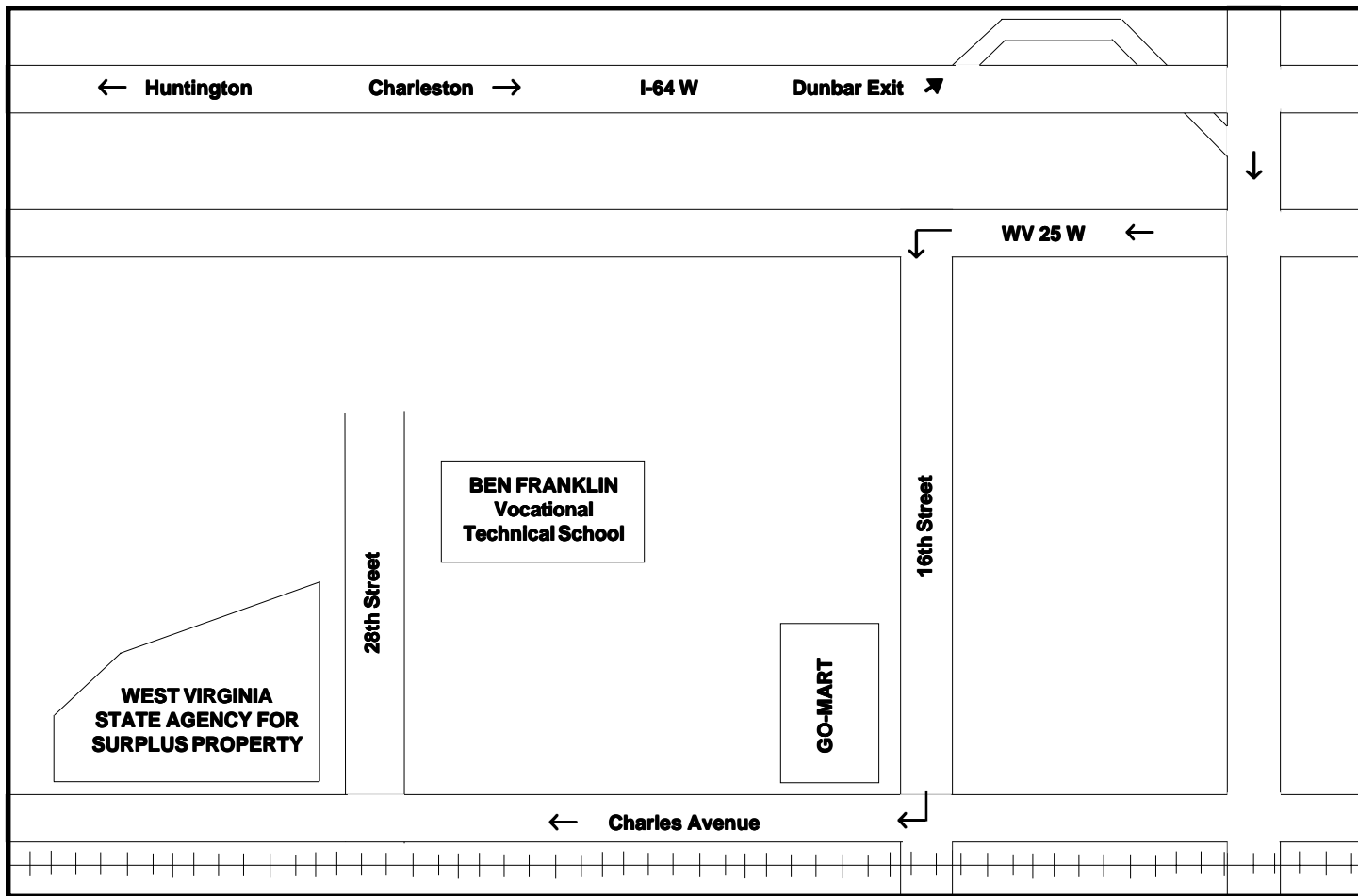

Terms: All organizations must present check — no cash. Organizations may be billed if proper credentials are presented. State agencies will be billed.

Terms and Conditions of Sale

FEDERAL & STATE REGULATIONS: Acceptance of Federal equipment and supplies by users who have established eligibility to participate in the WVSASP is subject to certifications and agreements identified on the reverse side of the Distribution Document.

1. Federal equipment and supplies are restricted to institutional use only, not personal use, and are to be used for a minimum of one year.
2. All vehicles and items with an acquisition cost of \$5,000.00 or more shall be used for the purpose(s) for which acquired within one year from the date the property was invoiced and used for 18 months thereafter.
3. During the restriction period, the property shall not be sold, traded, leased, lent, bailed, cannibalized, encumbered, or otherwise disposed of or removed from the State of West Virginia without the express approval of the WVSASP. The recipients of Federal property are urged to contact the WVSASP prior to taking any actions which might be interpreted as modifying any of the certifications and agreements stated on the reverse side of the Distribution Document.

TERMS: Net 30 days to all users unless previous arrangements have been made. Payment must be by check issued against an eligible organization. No personal checks, money orders or cash transactions are permitted.

SHIPPING: All service charges are FOB Dunbar Warehouse unless expressly indicated. Out-shipping can be arranged by calling (304) 766-2626. Delivery charges will be added to the invoice.
